## SUBMISSION INFORMATION & RULES **OMAHA FILM FESTIVAL 2024**

- To be eligible the film cannot have a public screening in Nebraska prior to the film festival (with the exception of collegiate screenings and touring Academy screenings).
- Nebraska Short Films: To be eligible for this category you must be a resident of Nebraska or the film has to have been shot primarily in Nebraska.
- Your film <u>cannot be viewable in its entirety online on sites like YouTube, Vimeo, or Facebook</u> before the festival screening to be accepted into OFF. Trailers or clips from the film are acceptable.
- All entries must be postmarked by the deadline date. All entries must be received by 11/20/23.
- Acceptable formats for submission: DVD or password protected online screener.
- All films that are not in English must have English language subtitles.
- Each entry must be a separate submission which includes form and payment for each submission.
- Entry Fees must be payable to "Omaha Film Festival" by check or money order. Fees from outside the US must be payable in US funds. No cash is allowed.
- Only submissions with completed entry forms and entry fee will be accepted.
- If you have listed a valid email address we will verify that we have received your entry.
- Exhibition DCP's must be sent to the Omaha Film Festival prepaid and return requests must include prepaid packaging.
- All Short Films must be no longer than 25 minutes in length.
- Enclosed with an entry for the Student Short fee must be a copy of a current student ID.
- Releases for music and talent must be obtained by the filmmaker. The Omaha Film Festival is not liable for copyright infringement or unauthorized use.
- If your film has been selected to be screened at the festival we will request you send a press kit to include: stills, posters, postcards, a digital file of the trailer, and other publicity materials to maximize exposure for your film. These materials will not be returned.
- The Omaha Film Festival does not assume any liability for damage to films, videos, or publicity materials.
- Film must have been completed after August 1, 2022.
- Filmmakers will be notified of festival acceptance by approximately February 10, 2024.
